However, this deposit is transferable and good for any mutually agreed upon future litter and will thus not expire. This deposit is Non-refundable if you cancel for any other reason.

Deposits are transferable if the Buyer decides on having another puppy/dog from the same litter or to transfer the deposit to a future litter. This option is only valid until (in case of a puppy) the puppy is six (6) weeks old. No transfer will be given after this age! This option is valid for one time only! So be 100% sure before requesting for this option, since the transfer is only available one time, after this there will be no transfer option available.

The Buyer hereby certify that he/she fully understands that the above mentioned deposit amount is **Non-Refundable** and that a transfer can be requested, but for **One Time** only, and that he/she enters this Deposit Agreement willingly.
