The Pomeranian puppy/dog described above is sold for the sum of R_____. A deposit of R_____ has been paid on (Date)_____ by the buyer and the remaining amount of R_____ must be paid in full at the time of Pick up (Date)_____, or transported (Date)_____ or by the date agreed upon by the Breeder and the Buyer, which is (Date)_____.

Sales conducted over the internet via email or any other method are legally binding and are considered part of the written contract. The Buyer understands that refusal to complete the payment for the Puppy and/or Dog bought from the Breeder, will result in the Buyer forfeiting the Puppy/Dog and any funds paid may be forfeited at the Breeders discretion for any and/or all expenses that may have been subjected to this Puppy or Dog. If the Buyer pays for the Puppy/Dog, but refuses to accept that Puppy/Dog on the determined date as stated above, he/she may be subjected to fees and fines for housing, care, any Vet Bills and any other expenses having to do with this Puppy/Dog for the time that the Puppy/Dog was held. If the Buyer fails to collect the Puppy/Dog in six (6) months time from the date of sale, the Buyer will forfeit the Dog as well as all funds paid towards the Dog and the Breeder reserves the right to re-sell the Dog to cover for any and all expenses incurred during the six (6) months period.

The Breeder hereby certify that the above mentioned KUSA registered Pomeranian Puppy/Dog will be transferred to the Buyer as soon as possible, after full payment has been made. Puppy's go to their new homes preferably between 10 to 12 weeks of age or at the Breeders determination. The Buyer understands that if he/she takes the Puppy before the ten (10) week inoculation, it will be done so at his/her own risk as

stated in the Health Warranty Agreement. The Breeder assumes no financial responsibility after the Puppy/Dog leaves the premises of the Breeder.

This Puppy/Dog comes with a 30-Day return guarantee (100% refund: 1-15 days after the date of delivery and 75% refund: 16-30 days after the date of delivery). The Buyer, however understands that this refund is only applicable to the purchase price and that the Deposit and Registration fee's is Non-refundable and that he/she is liable for any other out of pocket expenses.

The Buyer agrees that neither he/she nor the Buyer's estate/executors may sell this puppy/dog or transfer ownership of this puppy/dog without the Breeder's Knowledge and written consent. The Buyer hereby agrees that if at any time the Buyer cannot take proper care of the Puppy/Dog or no longer wants to own the Puppy/Dog for any reason, the Buyer must contact the Breeder and the Breeder will have the first choice of either: (a) take the Puppy/Dog back (not buy back) OR

(b) assist the Buyer in finding a suitable home for the Puppy/Dog.

By re-homing or by surrendering the Puppy/Dog to any veterinarian, emergency clinic or shelter for ANY reason, the Buyer is in a DIRECT VIOLATION of this contract and this can lead to litigation against all parties and/or a R5,000.00 penalty for liquidated damages. The Breeder reserves the right to reclaim this Puppy/Dog, with no compensation to the Buyer, if the dog is mistreated or neglected. If this is the case, the Buyer agrees to relinquish full ownership of the Puppy/Dog back to the Breeder and the Buyer accepts full responsibility for any and all veterinary costs incurred as a result of said mistreatment and/or neglect.

I love my dog's, and I will ALWAYS take them back at any age.

This Puppy/Dog is purebred and his/her parents are registered with the Kennel Union of South Africa (KUSA) and is sold with a **KUSA Registration Certificate** for breeding purposes. The Buyer acknowledges and agrees that it is not possible to predict the exact size, conformation and color of the Puppy as an adult and understands that the Puppy can not be returned as a result of this factor. In the event that the Puppy is no longer of breeding standard by the age of six (6) weeks, The Breeder agrees to replace the Puppy with one that is of breeding quality immediately or when available. A replacement is the only option!

Puppy's/Dogs that needs to be transported, will be transported with the most economical, but reliable, means available, unless the Buyer makes arrangements otherwise. Freight must be pre-paid by the Buyer and will NOT be refunded, should the dog be returned and/or a replacement puppy/dog send. The Buyer understands that ALL transport payable is for his/her account. A clean airline approved shipping crate, with food and water containers will be supplied for an additional cost.

The Buyer agrees to notify the Breeder of any changes of telephone numbers, address and email address during the Puppy/Dogs lifetime. The Buyer agrees to provide a suitable safe, escape free, fenced area for this Puppy/Dog. This will help keep the Puppy/Dog out of any shelter and keep him/her safe.

The Breeder neither makes nor implies any warranties or guarantees, expressed or implied, other than stated within this contract. This document constitutes the entire agreement between the Breeder and the Buyer with respect to this sale. The Buyer's signature below indicates that he/she has read, agrees and fully understands the content and all the conditions of the Sales Agreement within this contract, and therefore enters into this agreement willingly.
